There's No Obstacle We Can't Overcome,

“Our Brynnie girl is a Mono-Di twin—two sacs, and one placenta that our girls shared. Her twin sister’s name is Blake. My pregnancy was incredibly high-risk, and we had no idea how tough of a road we would have. To make a very long story short, I was monitored weekly with ultrasounds to make sure that the girls had even fluid levels and blood levels because they shared a placenta. One day in June, I had an appointment and the ultrasound did not turn out as well as we had hoped. Two days later, I found myself at the Cincinnati Children’s Hospital having a surgery called twin-twin transfusion (TTTS). It’s a condition in which the blood flows unequally between twins that share a placenta. They told me that Baby A, Brynnie Sue, was not doing well and she might not make it. There were two doctors that offered us to terminate Brynn before this surgery.



Luke and I said no, that is not our call, we knew we were blessed with two baby girls, and we would bring two home, by the grace of God! They did tell us that terminating Baby A, would not terminate Baby B, Blake Leigh. That option still did not matter to us, we wanted to do everything we could to save BOTH girls. Many hours later, we all survived this surgery, and they highly monitored Brynn for days.



The doctors were SHOCKED she survived because she was so close to death. Weeks later, we found out that Brynn had suffered a stage four brain hemorrhage while she was so sick during the surgery. We were then offered back in Indy the option to terminate her again, but we still said, NO. We would be bringing our girl home with us. We knew we had a long road ahead of us to bring our girls to term, but I was willing to do anything to keep them safe! There was bed rest, and limited lifting, which was challenging because we had their older brother at home with us, almost a year old at this point.

Many doctors told us Blake would survive, but Brynn had a VERY low chance of surviving outside of the womb. They said she would never breathe on her own, feed on her own, and everything else was a question mark to them. We had ONE neurologist say she believes she will breathe on her own, so Luke and I said, that's enough for us! We had faith of a mustard seed.



As a precaution, the hospital had asked us to make Brynn's funeral arrangements and plan out final details on how we would like to proceed in that way. Heart-wrenching is not a term that is large enough to describe this feeling. I was feeling the heavy weight of that truth, but Luke never ever waived on his belief that the Lord would protect both of our girls.

I was not due with our girls until November, but we delivered them on October 10, 2022. It was such a wonderful day, hearing BOTH of our babies cry! They instantly took Brynn to the NICU. She stayed there for 34 days, just to regulate her breathing. We prayed for a wireless baby to bring home. No oxygen, no feeding tubes, but pure, chunky baby girl. We got exactly that. Our girl came home to us with zero machines, and bottle-fed!

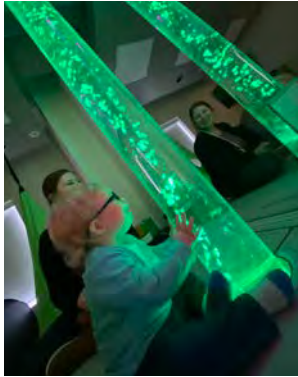
Luke and I were not told until the day we were leaving the NICU that Brynn might be visually impaired. That thought never crossed my mind before we were told this. I remember saying to them, “Well, we have made it this far, our girl is strong and a warrior. There is no obstacle we can’t overcome!”

Our girls are almost 15 months old now, and it has been the most challenging and rewarding year of our lives. Brynn has four different types of therapies, one of them being VIPS. Ms. Sheila is our VIPS “teacher” we say. We love having “class” with her. I knew the moment she walked through our front door she was meant to be in our family. We never want to let her go. She has already told us so many great things to do with Brynnie. She is a fighter for our family too, so we are so thankful to have her on our team! We have faced many obstacles along the road, but our strong girl seems to overcome every hurdle that has been thrown at her. She is small, but oh so mighty. Our girls are a true miracle, and warriors. I always say one could not have made it without the other. I’m not sure why the Lord chose us to be their parents, but I’m so very grateful He did. Brynn’s story is a redemption story. A little girl who will fight and be a warrior to the very end. To God be the glory.”

Summertime fun at VIPS!

VIPS Kids Town Preschool will close the book on another successful school year this May. On Wednesday, May 22, we will celebrate our twelve graduates as they receive their preschool diplomas. The celebration will continue the next day, May 23, when VIPS hosts our annual cookout benefiting the Crusade for Children. May 23 is our last day of school, too. We hope families will come to VIPS to mark the end of the school year while supporting one of our biggest supporters.

Our preschool team will take the next week to clean up from our school year and then set up for our summer program. We may let them catch their breath a bit, too.

Kids Town Preschool summer program is offered for two or three days a week for our current preschoolers. This special day will be filled with fun and safety tips as our little ones hone their travel skills. The VIPS O&M specialists are busy planning already. And let's not forget the other big push for the summer months! Our teachers will be attending trainings, conferences, and professional development days. We will be students at some and the instructors at others

Join us at the annual VIPS Gala this May

Last May, I attended the VIPS Gala for the very first time. At that point, I had been associated with this amazing organization, VIPS, for over 11 years as my daughter, Lola, is visually impaired and we received the VIPS services back in 2012 - 2014. Because the early intervention services made such an impact on not only Lola's life but my own as well, I joined the VIPS Indiana team as the part-time family services coordinator in 2014 and since then have gradually worked my way up through the nonprofit. I now proudly wear the Director of Community Outreach & Advocacy title.



But if I had worked at VIPS for so long, why hadn't I attended the Gala sooner? If I can be totally honest, Lola, her health, and her development consumed so much of my life that the thought of leaving her in Indianapolis so I could attend a fancy Gala in Louisville wasn't even on my radar. We were in survival mode—literally—trying to get Lola's intractable seizures identified and controlled. But over time, with the right neurologist and the right medication, Lola is now on a much better path and that has meant that I feel much more comfortable leaving her with loved ones. So when it came time for the 2023 Gala, I knew I wanted to be there and I'm so glad I went as I had a lovely time with my husband, Rob, and my other child, Sebastian. Since Lola is not too keen on crowded and unfamiliar environments she stayed home with Grandma and while it was fun having Sebastian in attendance—I think I would have been more relaxed if I wasn't in "Mom Mode" the entire evening.



Immediately upon arrival, champagne was available and check-in was quick and easy. We perused the fun silent auction items, took goofy pictures with props at the photo booth, felt glamorous getting our photo snapped at the Step & Repeat, and chatted with the attendees at our table. I had the pleasure of sitting with the generous folks from Kosair for Kids so it was nice

to be able to share firsthand what an impact VIPS can have on a family as we were living and breathing proof of it. Dinner would be served and it was delicious. I had never had Derby Pie, being from Michigan, so that was a welcomed treat! Throughout dinner, we heard from various speakers–Diane Nelson, executive director, and Jerry Bizer, long-time board member. What especially touched my heart was listening to the two VIPS families share about the importance of the services their children had or were receiving. There weren't many dry eyes in the room after hearing their stories. It was just the reminder we, the crowd, needed to hear as the auctioneer began his quest to dig into our pockets but for good reason—we were there to make a difference in the lives of these children. The live auction and Fund-A-Vision would help VIPS do just that as people opened their hearts (and wallets) generously. VIPS would raise close to \$130,000 that evening and as someone who went through the VIPS program, I couldn't have been more grateful for all of the support.

Our next Gala is set for May 11, 2024 at the Louisville Boat Club. We have a lofty goal this year—we hope to raise \$148,000. What can you do to help? Buy a ticket to the Gala or better yet—buy a table and invite all of your friends! If you can't make it that night, consider purchasing a silent auction item through our mobile bidding, buying a ticket for our Bourbon Pull, or you can simply donate. By doing so, you are helping VIPS serve families just like my own. I can't imagine where Lola's life would be without VIPS—and the same can be said for me. I've found my purpose through my career at VIPS. I get to ensure that other parents who have young kids with vision loss in Kentucky and Indiana are not alone on this unexpected journey in parenting as VIPS will be there every step of the way and that means everything to me. I hope to see you at the Gala in May!

Being the volunteer coordinator in Indy (one of my many hats), I get emails and calls from groups and individuals wanting to volunteer. One group in particular, that has been to the VIPS Family Resource Center (FRC) twice, led me to a woman who asked if it would be OK if she came back to the FRC again to make birthday cards that I send to our VIPS kids each month. She is a soft-spoken lady of few words and she reminds me of my sister-in-law, who even looks like her. I'll call her MB. MB would send me an email and we would set a day, usually once a month, or her to come in and work on cards for a couple of hours. I would set craft items and cards that needed edits out for her, and she would ask for nothing. No water, coffee, snacks, or anything. I felt my exceptional hosting skills were lost on her! She would never stay longer than two hours and her cards were always exceptional. I learned a lot about MB over the months she has volunteered with VIPS—she shared about her adult son who was diagnosed with MS, her husband's love of running, and the small office she has set up for making cards which I found out was her hobby and passion. MB came to the FRC in December to work on cards but only stayed one hour. On her way out she handed me a small envelope and I thought, "Oh how nice, she made me a Christmas card."



It sat on my desk for an hour then I decided to open it and it was much more than just a card. MB had written a check for \$2,500.00 to VIPS. I sat stunned and in tears. Here was a woman who just wanted to do good in the world and she could have chosen to spread her kindness anywhere and yet she chose VIPS. Her generosity hit me hard but in the best way. I feel emotional when I think of her kindness. I haven't heard from MB for any future dates but I know I will and I also know she doesn't want to be treated any differently. She just wants to volunteer and make cards for VIPS. I couldn't be more thankful for this special woman who has come into my life through VIPS. She has made quite an impact on me!

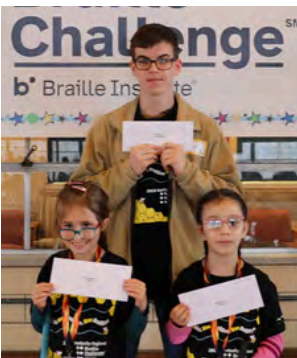
