VIPS EMPLOYS HIGHLY TRAINED, CERTIFIED TEACHERS OF THE VISUALLY IMPAIRED AND EARLY CHILDHOOD EDUCATORS WHO WORK WITH FAMILIES IN THEIR HOMES, TEACHING PARENTS HOW TO EDUCATE BY CAPITALIZING ON THEIR CHILDREN'S STRENGTHS.
